After meeting for several years in Columbia, the SC Conservation Partnership returned to Charleston for the 2020 Annual Conference. Over 250 district commissioners, employees, DNR and NRCS staff, and friends were in attendance.

The conference began with a luncheon meeting of the SC Soil and Water Conservation Society, followed by the SCACD Policy Committee meetings. The next day featured a keynote speech by new DNR Director Robert Boyles who focused on coastal conservation issues, followed by presentations and discussion on the issues from experts from Conservation Districts, NRCS, DNR, Clemson Extension, and the SC Conservation Bank. The afternoon session topics included Clemson Extension Water Programs and Long Leaf Alliance Programs. In spite of the rainy weather, the day concluded with a tour of the DNR Marine Research Center at Fort Johnson. That evening featured the Partnership Awards Dinner including an inspirational message from Mr. Kirby Player with Clemson's Environmental, Agriculture and Forestry Institute.

Message from SCACD's President Jeff Wilson

My fellow conservationists, April 2, 2020

I would like to thank all of you for the opportunity of serving as your SCACD President for the next two years. Since our recent conference in Charleston, nearly every aspect of our lives has been drastically altered as our nation wrestles with the threat of the COVID-19 Virus. How do we continue on with our important work of conservation even as we face these foreboding circumstances? We need only to look back to the events which led to the birth of our organization to realize that even in the worst of times, positive developments can result. The conservation movement was rooted in an unforeseen disaster commonly known as the Dust Bowl. The simulators demonstrate the importance in good ground cover by its effect on the soil's ability to retain water from rainfall. SC Districts receive NACD Technical Assistance Funds

Five SC Districts approved for funding

In 2018, the National Association of Conservation Districts (NACD) offered cooperative agreements to provide funding to Districts to hire staff to enhance technical assistance related to EQIP contracts. Five Districts in South Carolina received funding the first year, providing assistance on 636 EQIP contracts covering over 62,000 acres.

In 2019, the program was expanded to include technical assistance on CSP contracts in addition to EQIP. Districts participating include Barnwell, Clarendon, Horry, Orangeburg and Williamsburg with the total agreement amount statewide of \$179,000.

A third year of grants will be offered in 2020 to include technical assistance on EQIP, CSP and conservation planning. Major funding is provided through NRCS with a 20% match from each district.



Ben Setzler, SCACD's current Vice President and Newberry Soil and Water Conservation District's Chairman, along with Brooke Myres, SCDNR-Conservation District's Program Development Manager, have been accepted as participants in the first cohort of South Carolina's Palmetto Leadership Program for the Environment, Agriculture and Forestry (P-LEAF)! P-LEAF is a two-year intensive academic, experiential learning and networking curriculum designed to facilitate personal and professional growth and success, while sharpening character and leadership skills for each participant. P-LEAF is housed and directed by Clemson University's College of Agriculture, Forestry and Life Sciences (CAFLS) and Public Service and Agriculture Division in conjunction with key program related cooperating partners.

SCACD Contribution Agreements to Districts - Successful and Growing!

In 2016, SCACD entered into a Contribution Agreement with NRCS to coordinate technical and administrative assistance on EQIP contracts. In that first year, SCACD was allocated \$300,000 for this program, with \$250,000 available to Districts. The year began with over \$267,000 in requests with 12 Districts participating, eventually growing to include 15 Districts.

In FY 2018, with another allocation of \$250,000 available to Districts, SCACD received requests in the amount of \$314,180, beginning the year with 14 Districts and growing to 19 Districts. FY 2019's allocation, again at \$250,000, was 100,000 short of meeting the requested need of Districts at \$351,240.

SCACD's tracking of requests and management of the program prompted NRCS to offer an additional \$100,000 for FY 2020. The Contribution Agreement supports local staff in the District offices and has grown from supporting 12 employees in 2016 to over 30 in 2020!

State Water Plan Update

SCDNR is happy to announce that the Edisto River Basin Council for the State Water Plan has been selected and that two of the selected individuals for the Council include Laura Bagwell, Aiken District Commissioner, and Johny Haralson, Barnwell District Commissioner. These two were chosen as District Representatives for the Council. Jeremy Walther, Aiken District Associate Commissioner, was also chosen to serve on the Council. The Edisto River Basin Council plans to begin convening after COVID-19 concerns and restrictions have passed. This will be a 2-year planning process. We appreciate these Conservation District Representatives making the commitment to be a part of the State Water Plan Process. Stay tuned for other river basin council announcements in the near future.

Its programs and activities are aimed at advancing the resource conservation cause of the Districts and the cooperating landowners, land users and citizens whom they serve in their communities. Mobile Irrigation Project

The Mobile Irrigation Lab (MIL) is a locally-led water conservation project involving multiple partners across all levels of governmental and private entities. The Aiken Conservation District is leading the initiative through fostering funding partners and serving as the project manager. The MIL pilot project will provide water and energy audits on 24 agricultural center pivot irrigation systems throughout the state of South Carolina at no charge to the agricultural producer. The goal of this project is to determine the feasibility of a statewide MIL program that can be implemented throughout South Carolina to agricultural producers at no cost.

“We were approached by a local farmer who brought the idea of establishing a Mobile Irrigation Laboratory in the state of South Carolina” said Yvonne Kling, Aiken District Chair. “We felt that as a Soil and Water Conservation District, we had to make the effort to establish this MIL pilot project. We also wanted to ensure that this came at no cost to agricultural producers who were willing to participate.”
